Annual Meeting Overview

We invite you to join us for our Annual Meeting at the Lions Club on Saturday, August 24 at 9 A.M. We have a lot to cover as you will see in this newsletter and the highlights below.

Last year we began our transition to hiring and managing our own team of employees, albeit not by choice, but we learned it enables us to be more accountable to our community and to provide better care for our lakes and equipment. This summer we are again blessed to work with a talented and dedicated team of employees led by our crew chief, Scott Center.

Our new 7 ft. Aquarius harvester was delivered to Rice Lake in May, and it will be a boon to our harvesting efforts on that lake. Half of the cost of the harvester was paid by a grant from the Wisconsin DNR.

The DNR also approved a new, ten-year permit for bog harvesting with the possibility of a five-year extension. We issued a request for proposal for our fall bog work; if you know someone who might be interested, please let us know.

We will present a proposed 2025 budget and five-year capital plan to the membership, as well as six proposed bylaw amendments recommended by our Board. The first three revisions conform District bylaws to Wisconsin State Statutes.

Since the sale of JNT in 2022, the Board has explored permanent solutions for storing and maintaining our equipment. This issue has been discussed on and off at Annual Meetings since the Lake Management District was formed in the late 1980's. We will update our efforts including potential options and funding sources.

Lake volunteers assisted the Department of Agriculture round up of 53 geese on the south end of Whitewater Lake. We are grateful for the efforts Ernie Roy and his team for removing these disease carrying birds from our waters.

We are fortunate to have a well-staffed and experienced team to lead our lake safety efforts. This year the sheriff's patrol, again led by Captain Jake Hintz, includes two, newly retired policemen, one of whom is the former chief of police in the City of Whitewater. We look forward to hearing from Walworth County Sheriff Dave Gerber.

We will honor Rich Charts for his 17 years of service to the Lake Management District, including 12 years as chair. We are grateful to Rich for his wonderful leadership and we are pleased to introduce Bob Sczinski, a lake homeowner and a strong candidate who is running for Rich's seat.

Come and learn about our plans and costs, add your input, and vote on items identified in this newsletter. The GWLPOA, which helps build a strong sense of community across the lake district, will also present their annual report and slate of candidates.

You are invited to arrive early at the Lions Club and have coffee and snacks while you meet and greet your neighbors. Free-will donations for the homemade snacks will be used to support Walworth County's K-9 unit. Hope to see you on the 24th!

Chemical Treatments

Lake and Pond Solutions (LPS), our current provider for chemical spraying, surveyed both lakes in early May to identify and map weed growth and submit their treatment recommendations to the Wisconsin DNR. Based on the contractor's survey results and cost estimates, the board authorized LPS to treat Eurasian Milfoil on 69.7 acres of Whitewater Lake. The District elected not to treat Rice Lake, however, based on the DNR's recommendation and is instead managing the weeds there with our new, 7 ft. harvester. The approved Whitewater Lake spraying map is available on the Operations page of our website.

We are conducting a barley straw experiment on Rice Lake with the Wisconsin DNR to determine whether barley straw can slow the growth of algae. In the experiment, which we are funding, we hang bags of barley straw under piers in two areas and send water samples from there as well as a control site to the Wisconsin State Lab of Hygiene for analysis. Results from last summer's efforts, which are available on our website, did not show measurable improvement much as we expected for the first year. We hope to see positive results in the next year or two.

Equipment Report

We had a smooth start to the 2024 harvesting season getting all the equipment ready for operation. Scott Center, our crew chief, and our harvesting crew removed all the equipment from winter storage and got it prepped and launched by May 31.

Our new 7 ft. harvester, which replaced an older, inoperative unit, was originally scheduled for delivery in 2025. We received good news this spring that the new harvester was moved up on the production schedule by the manufacturer (Aquarius Systems), enabling us to accept delivery on May 23.

The new harvester was launched on Rice Lake and will remain there for the harvesting season, as needed. Presently all equipment is fully operational, with both Whitewater and Rice Lakes benefiting from harvesting operations. Moving forward, the Board will continue planning to replace older equipment and searching for a property/storage facility for all the Lake District equipment

The first bog of the year rose in mid-June, two weeks ahead of 2023. Last year we had a new crew and tried a different dredge machine. Learning new techniques, we still picked up many truckloads of floating debris from the navigation lanes, as well as floaters that had been floating up to shorelines and under piers.

On-the-job training cost was costly, however, and last fall we exceeded our bog harvesting budget. This year we are legally mandated to repay capital funds that we borrowed last year to pay our contractor, so bog harvesting likely will be limited to navigation lanes and shoreline pickups. Be careful of the hidden bogs below water level.

We were granted a new, ten-year bog harvesting permit from the DNR this spring, with the potential for a fiveyear extension. Our primary goal remains safety and navigation hazard removal with a secondary goal of nutrient removal.

Weed Harvesting

This year the main thrust of our early season harvesting effort was to remove as much curly leaf pondweed as possible since this invasive weed grows early, forms mats on the surface of the water, and typically dies off by mid-June. Once it dies, its seed pods remain active and can germinate as soon as mid-summer or for up to five years, even if they were sprayed with herbicide. Unless we harvest these plants, they ultimately sink to the bottom where the plant material decomposes and releases phosphorus, which contributes to algae growth.

According to surveys conducted in May, curly leaf is the dominant invasive species on Rice Lake this year while Eurasian milfoil is the predominant weed on Whitewater Lake. Pockets of curly leaf can be also found on Whitewater Lake, however, around the south end and in Isabella Bay and several other areas.

We began harvesting on Whitewater Lake in early June following the mandatory two-week waiting period after we sprayed for milfoil there in May. On Rice Lake our DNR permit prohibits us from harvesting until after June 30 when fish spawning is completed. This year, however, we obtained special permission from the DNR to begin harvesting curly leaf pondweed strictly in the navigation lanes in mid-May before it died and settled to the bottom.

As this article is being written, we are finding only modest amounts of Eurasian milfoil to harvest on both lakes. The curly leaf pondweed that emerged this spring has already been harvested. We do not know how densely these invasives will grow throughout the rest of the summer, but our crew is fully staffed and ready to tackle weed growth in any areas where we are permitted to cut.

Fish Management

It was a quiet winter for fishing. Thin ice forced the Lion's Club to cancel its Fish-A-Ree Ice Fishing Tournament, and medical issues kept the carp netting contractor off Rice Lake. However, based on catch reports, fishing was off to a good start in May, with several "keeper" walleye pike being caught, along with the usual assortment of bass, northern pike and panfish.

Last fall, the Wisconsin DNR stocked over 6,000 seveninch juvenile walleye pike, while your Lake Management District stocked 800 black crappie and 960 yellow perch. This year, the DNR will not be stocking Whitewater Lake since its surveys indicate healthy fish populations there. Stocking for Rice Lake is on hold pending completion of water improvement programs. The Lake Management District will continue our own fish stocking efforts this fall, however, most likely perch and crappie.

We now have four fish cribs in place in Whitewater Lake, and sonar images confirm fish are using the artificial habitat as a place to hide. I just caught two relatively small, northern pike, suggesting the larger fish may be naturally reproducing. I appreciate photos and stories about the "big ones" you catch, but information about the little ones is useful too.

Safety Team Report

We thank him for his time and efforts to make boating on our lakes a lot safer. With Sean's departure, there will be a hole in leading the program. If you or someone you know may be interested in teaching or assisting the class for the 2025 boating season, please contact me or Carol Ducommun. It is not a big commitment of time, and it will be of great service to the boating public.

Lakeshore Management

Night skies around Whitewater and Rice Lake provide some of the best stargazing opportunities in the area. The surrounding State Forest limits artificial light sources to allow the moon and stars to take center stage. Starting mid-July and lasting through August, the Perseids meteor shower will be visible in our area, producing 50-75 shooting stars every hour.

Keeping your exterior lights to a minimum will provide the best viewing experience and allow wildlife to maintain their natural rhythms of day and night. Best practices include using exterior lights only where needed, pointing lights downward, using timers, and using low-intensity, warm-colored bulbs. Please be courteous to your neighbors, both human and animal, and turn off non-essential lighting in the evening.

Financial Results

In 2023 the Lake Management District incurred a loss of \$19,600 due to overspending on our fall bog harvesting efforts, requiring us to borrow from our capital reserves to pay our harvesting contractor. The Board subsequently passed a revised financial plan for 2024 to reduce spending and restore our capital, as we are required to do. Compared to the 2024 budget, the financial plan reflects lower spending on weed harvesting, chemical treatment and bog removal. These savings will be slightly reduced by increased expenditures for equipment storage, accounting services, and insurance as we continue our transition to operating without a subcontractor.

Consistent with the past three years, chemical costs in 2024 reflect spraying only Whitewater Lake, and not Rice Lake. In May we treated 69.7 acres on Whitewater Lake with ProcellaCOR, advertised as a three-year solution for treating Eurasian Milfoil which is the predominant invasive weed there. For 2025, we are reducing the chemical budget by \$10,000 from the 2024 plan and are investigating using a lake management consultant to help us make decisions about managing aquatic invasive species on both lakes.

Our new, DNR-approved, ten-year bog harvesting plan approved the removal of approximately 10,000 cu. yd. of bog material over 10 years, or roughly 1,000 cu. yd. per year. Last fall, we hired a contractor with dredging equipment to work in conjunction with our harvesting crew who operated our equipment including our

transport barge, shoreline conveyor, large dump truck, and a harvester. Together they worked for 19.5 days and removed 2,550 cu. yds. of bog material. This fall we are targeting 7-8 days of bog harvesting to yield 1,000 cu. yds. and to operate within the constraints of our 2024 financial plan. The 2025 budget will be increased to support approximately 11.5 days of operation yielding 1,500 cu. yds. Our primary focus continues to be removing bogs from navigation lanes and residents' lakefronts.

Our five-year capital plan reflects the purchase of our 7 ft. weed harvester that was delivered in May at a cost of \$269,500, offset by a 50% DNR grant, and a new 10 ft. harvester in 2026/2027 to replace our existing 10 ft. harvester. The capital plan also includes a 30% downpayment for 2025 to purchase land and a building for \$450,000 to store and maintain our equipment as discussed at last year's annual meeting.

Our 2023 storage expenses reflect higher costs than anticipated to find large space with 15 ft. high doors to accommodate our large equipment. Storage costs in 2024 include additional space for our new 7' harvester, while 2025 costs include seven months of debt service for a building instead of rental costs. Legal and professional costs for 2025 reflect real estate closing costs and increased insurance for the new building and a full year with the new harvester.

Recommended 2024 Changes to District Bylaws

The Board recommends approval of the following changes to our bylaws, which were most recently amended in 2013. The first three items are recommended to conform our bylaws with Wisconsin State Statutes and the remaining items are minor clarifying changes. Our bylaws can be found on the "About" page of our website.

- 1. Article II will be amended to confirm that the parties who can vote at the Annual Meeting includes all electors and all real property owners whose name appears on the District's tax roll.
- 2. Article V
 - a. Section 2 will be amended to allow email notifications to electors and property owners who have agreed to receive such notice.
 - b. Section 5 will be amended to clarify that any elector or property owner may add items to the Annual Meeting agenda by submitting a petition at least 30 days prior to the meeting (as opposed to the 45 days currently provided) and delete the phrase "as the board may determine."

- 3. Article VI will be amended to delete the restriction on Board members or their family conducting business with the District.
- 4. Article I: will be amended to clarify that the District does not own nor have control over Rice Lake Dam.
- 5. Article IV Section 2: will be amended to change the current requirement requiring an "audit committee" of three electors to a requirement that it obtain an "Independent Financial Review" as recommended by the Wisconsin Lakes organization
- 6. Correct spelling of "voter roll" throughout the document.
